#### **COMMUNICATIONS TO THE BOARD**

2015 Budget Update presented by Business Manager Penrod. The referenced Cash Flow Worksheet is used for preliminary budget information as well as to formulate predictions. Our BASIC GRANT payment went down in July by roughly \$8,000. The Cash Flow Worksheet was built with a significant decrease beginning in July anticipating that the actual decrease in funding was likely. Actual dollars received were more than the amount that Mr. Penrod built in to the final six months of 2014. We will continue to receive this amount until the ADM is accounted for (usually reflected in the November payment). Mr.

Penrod also included a 2015 Budget Worksheet in Board members' packets. This will be a starting point, using IDOE data for building the 2015 General Fund budget.
