If students are not checking in, teachers and office staff are reaching out to those students. • Close to 40 hot spots have been handed out with very few computer issues. • Last student day is 5/15/20 and last teacher day is 5/18/20. We have attended 162 days with 9 waiver days and 29 e-learning days. • We continued to pay spring coaches.
